Carl Gilmore Managing Director, KCG Futures




Topic: Futures Market Function

Speakers' Bio:

Carl Gilmore is a managing director and chief executive officer of KCG Futures, the futures division of Knight Capital Americas LLC. Previously, he was global enterprise risk officer for Penson. Before that he served as general counsel for Penson GHCO, a wholly owned subsidiary of Penson Worldwide Inc. (PNSN). He also serves as a member of the NFA Compliance and Risk Committee. Gilmore is a member of the National Futures Association, American Bar Association, Chicago Bar Association, Global Association of Risk Professionals (GARP), as well as the Futures Industry Association, Law and Compliance Division. Gilmore has a Bachelor of Science from Indiana State University, an MFA degree from the University of Chicago, and a Juris Doctor degree from John Marshall Law School in Chicago.

Rick Lane is the CEO of Trading Technologies (TT), a Chicago-based privately held independent provider of professional trading software. Previously, he was the executive vice president and chief technology officer at TT. He was appointed CTO on April 2, 2012 and became CEO on February 5, 2014, replacing Harris Brumfield. He rejoined the company from Google, where he had worked as a product manager on their display ad serving technology. He first joined TT in June 2010, when TT acquired the company he cofounded, TickIt Trading Systems. Mr. Lane graduated with a BS in Computer Science from Georgia Tech.



Chris Hehmeyer is managing member of HTG Capital Partners, LLC, a proprietary trading group. He also serves as the non-executive vice chairman of KCG Futures, a futures commission merchant. Additionally, Hehmeyer is the current chairman of the board of the National Futures Association (NFA). Hehmeyer is a member of the board of directors of the Futures Industry Association (FIA), where he has served in several capacities, including vice-chairman of the board. Mr. Hehmeyer was one of the founding partners of Goldenberg, Hehmeyer & Co. He was a managing director of Virginia Trading Corporation from 1981 until the establishment of the GHCO partnership in 1984. When GHCO was sold to Penson Worldwide, Hehmeyer became the CEO of Penson GHCO. He later stepped down and became non-executive chairman of the firm. Mr. Hyhmeyer graduated with a BA in Political Science from The University of the South.
